A GENERALIZATION OF THE STRONGLY CESÁRO IDEAL CONVERGENCE THROUGH DOUBLE SEQUENCE SPACES

Abstract: In this paper, some algebraic properties of Cesáro double ideal convergent sequence spaces are defined and proved. Those spaces are defined as C_{nm}^I and C_{0nm}^I . Furthermore, this paper shows some inclusion relations on these spaces which are established and proved.

1. Introduction and preliminaries

The notion of strong Cesáro convergence was initially defined by [2], this notion was defined as: A sequence (x_n) on a normed space $(X, \|\cdot\|)$ is called strongly Cesáro convergence to L if

 $\lim_{n\to\infty} 1/k \sum_{n=1}^{k} ||x_n - L|| = 0$. In [4, 9], the authors have extended this notion in several fields. Fast [10] in 1951 introduced the concept of statistical convergence, at the same time Steinhaus [11] in 1951 by his own way defined the notion of ordinary and asymptotic convergences. After that, Fridy [12, 13] studied the statistical convergence and he created a relation which linked this notion with the notion of summability theory. On the other hand, Kostyrko et al. [14] in 2000 showed the concept of ideal convergence which was a generalization of statistical convergence. Some years after, Salat et al. [5] studied

some properties of *I*-convergence, and then it has been studied by many mathematicians. Recently, in 2020, Faisal [1] defined the concept of strongly Cesáso ideal convergent and proved some properties.

Now, we show some definitions and previous results which are useful for the developing of this paper.

Definition 1. ([3]) Let $2\omega = \{x = (x_{nm}) : x_{nm} \in R \text{ or } C\}$ of all real and complex double sequences, where R and C denote the real number set and complex number set, respectively.

Definition 2. ([3]) A double sequence $x = (X_{nm}) \in 2\omega$ is said to be double *I*-convergent to a number *L* if for every $\epsilon > 0$, we have

 $\{(m,n) \in N \times N : |x_{nm} - L| \ge \epsilon\} \in I.$

In this case, we write $I-\lim x_{nm} = L$.

Definition 3. ([14]) Let X be a non-empty set. Then a family of sets $I \subseteq 2^X$ is said to be an ideal in X if the following statements hold:

- 1. $\emptyset \in I$.
- 2. If $A \subset B$ and $B \in I$, then $A \in I$.
- 3. If $A, B \in I$, then $A \cup B \in I$.

Moreover, and ideal I is called admissible if $\{\{x\} : x \in X\} \subseteq I$.

Definition 4. ([3]) A non-empty set $F \in 2^X$ is known as a filter in N if satisfies the following statements:

- 1. $\emptyset \in F$.
- 2. $A, B \in F$, then $A \cap B \in F$.
- 3. $A \in F$ with $A \subseteq B$, then $B \in F$.

Remark 5. For every ideal *I*, there is a filter F(I) (associated with *I*) defined as $F(I) = \{P \subseteq N \times N : P^c \in I \text{ where } P^c = N \times N - P\}.$

Lemma 6. (See [5]) Let $W \in F(I)$ and $M \subseteq N$. If $M \notin I$, then $M \cap W \notin I$.

Lemma 7. (See [5]) Let $I \subseteq 2^N$ and $M \subseteq N$. If $M \notin I$, then $M \cap W \notin I$ and $W \in F(I)$.

Definition 8. A double sequence space of X is said to be solid if $(\gamma_{nm}x_{nm}) \in X$ whenever $(x_{nm}) \in X$ and (γ_{nm}) is a sequence of scalars with $|\gamma_{nm}x_{nm}| \leq 1$, for all $(n,m) \in N \times N$.

Definition 9. A double sequence of X is said to be a sequence algebra if for every $(x_{nm}), (y_{nm}) \in X, (x_{nm}, y_{nm}) \in X$.

2. Results

We first introduce the notion of C_{nm}^{I} which denotes the space of all Cesáro double *I*-convergent sequences. Besides, we also introduce the notion of C_{0nm}^{I} which denotes the space of Cesáro double ideal null sequences. Those notions are given as follows:

Definition 10. $C_{nm}^{I} = \{x = (x_{nm}) \in 2\omega : \{(n,m) \in N \times N : I - \lim_{k \neq j \to \infty} \frac{1}{k j} \sum_{n = 1}^{k j} ||x_{nm} - L|| = 0\}, \text{ for some } L \in C\} \in I.$

Definition 11. $C_{0nm}^{I} = \{x = (x_{nm}) \in 2\omega : \{(n,m) \in N \times N : I - \lim_{kj \to \infty} \frac{1}{kj} \sum_{nm=1}^{kj} ||x_{nm}|| = 0\}\} \in I.$

Theorem 12. The sequences spaces C_{nm}^I and C_{0nm}^I are linear.

Proof. Let $x = (x_{nm})$ and $y = (y_{nm})$, where $x, y \in C_{nm}^{I}$. Then, we have that

$$I - \lim_{kj \to \infty} \frac{1}{kj} \sum_{nm=1}^{kj} ||x_{nm} - L|| = 0 \text{ for some } L \in C,$$
$$I - \lim_{kj \to \infty} \frac{1}{kj} \sum_{nm=1}^{kj} ||y_{nm} - L_0|| = 0 \text{ for some } L_0 \in C.$$

Now, let

$$\mathcal{V}_1 = \{ (n,m) \in N \times N : \frac{1}{kj} \sum_{nm=1}^{kj} \|x_{nm} - L\| \},$$
(1)

$$\mathcal{V}_2 = \{ (n,m) \in N \times N : \frac{1}{kj} \sum_{nm=1}^{kj} \|y_{nm} - L_0\| \}.$$
(2)

Now, let γ and ϕ be any two scalars. Taking into account the properties of norm, we have that

$$\lim_{k_{j\to\infty}} \frac{1}{k_{j}} \sum_{nm=1}^{k_{j}} \|(\gamma x_{nm} + \phi y_{nm}) - (\gamma L + \phi L_{0})\|$$

$$\leq \lim_{k_{j\to\infty}} \frac{1}{k_{j}} |\gamma| \|x_{nm} - L\| + \lim_{k_{j\to\infty}} \frac{1}{k_{j}} |\phi| \|y_{nm} - L_{0}\|.$$

Thus, from (1) and (2), we have that for every $\epsilon > 0$,

$$\{(n,m) \in N \times N : \lim_{k \neq \infty} \frac{1}{k j} \sum_{n = 1}^{k \neq j} \|(\gamma x_{nm} + \phi y_{nm}) - (\gamma L + \phi L_0)\|$$
$$\geq \epsilon\} \subset \mathcal{V}_1 \cup \mathcal{V}_2.$$

Therefore, $(\gamma x_{nm} + \phi y_{nm}) \in C_{nm}^{I}$ for all scalars γ, ϕ and $(x_{nm}), (y_{nm}) \in C_{nm}^{I}$. In consequence, this implies that C_{nm}^{I} is a linear space.

The proof of C_{0nm}^{I} is a linear space is proved in the same manner of the C_{nm}^{I} .

Proposition 13. Let $x = (x_{nm}) \in \omega$ be any double sequence, then $C_{0nm}^I \subset C_{nm}^I$.

Proof. The proof is followed by the Definitions 10 and 11. \Box

Theorem 14. The space C_{0nm}^I is solid.

Proof. Let $(x_{nm}) \in C^{I}_{0nm}$ be any element. Then, we have that

$$\{(n,m) \in N \times N : I - \lim_{kj \to \infty} \frac{1}{kj} \sum_{nm=1}^{kj} ||x_{nm}|| = 0\}.$$

Now, let (γ_{nm}) be a double sequence of scalars such that $|\gamma_{nm}| \leq 1$, for all $nm \in N \times N$. So, we get that

$$\frac{1}{kj}\sum_{nm=1}^{k}|\gamma_{nm}| \le 1.$$

Then, from the above inequality, we have that

$$\frac{1}{kj} \sum_{nm=1}^{kj} \|\gamma_{nm} x_{nm}\| = \frac{1}{kj} \sum_{nm=1}^{kj} |\gamma_{nm}| \|x_{nm}\|$$
$$= \frac{1}{kj} \sum_{nm=1}^{kj} |\gamma_{nm}| \frac{1}{kj} \sum_{nm=1}^{kj} \|x_{nm}\| \le \frac{1}{kj} \sum_{nm=1}^{jk} \|x_{nm}\|$$

for all $(n,m) \in N \times N$. Therefore, the space C_{0nm}^{I} is solid.

Theorem 15. A double sequence $x = (x_{nm}) \in C_{nm}^I$ is double *I*-convergent if and only if for every $\epsilon > 0$, there exists $t = t(\epsilon) \in N \times N$ such that

$$\{(n,m) \in N \times N : \frac{1}{kj} \sum_{nm}^{kj} ||x_{nm} - x_t|| < \epsilon\} \in F(I).$$

Proof. We begin proof \Rightarrow :

Consider $x = (x_{nm}) \in C_{nm}^{I}$. Then, $I - \lim_{k \to \infty} \frac{1}{kj} \sum_{nm}^{kj} ||x_{nm} - L|| = 0$. Thus, for all $\epsilon > 0$ the set

$$C_{nm}^{\epsilon} = \{(n,m) \in N \times N : \frac{1}{kj} \sum_{nm}^{kj} ||x_{nm} - L|| < \frac{\epsilon}{2}\} \in F(I).$$

Fix a $t(\epsilon) \in C_{nm}^{\epsilon}$, then we obtain

$$\frac{1}{kj}\sum_{nm}^{kj}\|x_{nm} - x_t\| \le \frac{1}{kj}\sum_{nm}^{kj}\|x_{nm} - L\| + \frac{1}{kj}\sum_{nm}^{kj}\|x_t - L\| < \frac{\epsilon}{2} + \frac{\epsilon}{2} = \epsilon$$

which holds for all $(n,m) \in C_{nm}^{\epsilon}$. Therefore,

$$\{(n,m) \in N \times N : \frac{1}{kj} \sum_{nm}^{kj} ||x_{nm} - x_t|| < \epsilon\} \in F(I).$$

Now, we proof \Leftarrow : Consider that for all $\epsilon > 0$, the set

$$\{(n,m) \in N \times N : \frac{1}{kj} \sum_{nm}^{kj} ||x_{nm} - x_t|| < \epsilon\} \in F(I).$$

Then, for every $\epsilon > 0$, we have that

$$M_{nm}^{\epsilon} = \{(n,m) \in N \times N : \frac{1}{kj} \sum_{nm}^{kj} ||x_{nm}||$$

$$\in [\frac{1}{kj} \sum_{nm}^{kj} ||x_t|| - \epsilon, \frac{1}{kj} \sum_{nm}^{kj} ||x_t|| + \epsilon]\} \in F(I).$$

We will denote $W_{nm}^{\epsilon} = \left[\frac{1}{kj}\sum_{nm}^{kj} \|x_t\| - \epsilon, \frac{1}{kj}\sum_{nm}^{kj} \|x_t\| + \epsilon\right].$

For fixed $\epsilon > 0$, we have that $M_{nm}^{\epsilon} \in F(I)$, as well as, $M_{nm}^{\epsilon/2} \in F(I)$. Therefore, $M_{nm}^{\epsilon} \cap M_{nm}^{\epsilon/2} \in F(I)$. This implies that $M_{nm}^{\epsilon} \cap M_{nm}^{\epsilon/2} \neq \emptyset$. Thus,

$$\{(n,m) \in N \times N : \frac{1}{kj} \sum_{nm}^{kj} ||x_{nm}|| \in W_{nm}\} \in F(I).$$

For this, we have $diam(W_{nm}) \leq diam(W_{nm}^{\epsilon})$, where $diam(W_{nm})$ denotes the length of the interval of W_{nm} . In this way, by induction, we have the sequence of closed intervals $W_{nm}^{\epsilon} = U_{nm}^{0} \supseteq U_{nm}^{1} \supseteq ... \supseteq U_{nm}^{5} \supseteq ...$ With the property that $U_{nm}^{i} \leq 1/2 diam(U_{nm}^{i-1})$, for i = 1, 2, 3, ... and

$$\{(n,m) \in N \times N : \frac{1}{kj} \sum_{nm}^{kj} ||x_{nm}|| \in U_{nm}^i\} \in F(I),$$

for i = 1, 2, 3, ... Then, there exists a $L \in \cap U_{nm}^i$ such that

$$L = I - \lim_{kj \to \infty} 1/kj \sum_{nm}^{kj} ||x_{nm}||.$$

This proves that $x = (x_{nm}) \in C_{nm}^{I}$ is double *I*-convergent.

Theorem 16. Let $x = (x_{nm})$ and $y = (y_{nm})$ be any two double sequences such that $T(x \cdot y) = T(x)T(y)$. Then, the space C_{nm}^{I} and C_{0nm}^{I} are sequence algebra.

Proof. Let $x = (x_{nm})$ and $y = (y_{nm})$ be any two elements of C_{nm}^{I} with $T(x \cdot y) = T(x)T(y)$. Now, for every $\epsilon > 0$ choose $\lambda > 0$ such that $\epsilon < \lambda$. Then, we have that

$$\{(n,m) \in N \times N : \frac{1}{kj} \sum_{nm}^{kj} \|T(x_{nm}) - L_i\| < \frac{\epsilon}{2\lambda}\} \in F(I)$$

and

$$\{(n,m) \in N \times N : \frac{1}{kj} \sum_{nm}^{kj} ||T(y_{nm}) - L_p|| < \frac{\epsilon}{2L_i}\} \in F(I).$$

Taking into account the above and the properties of norm, we have that

$$\frac{1}{kj} \sum_{nm}^{kj} \|T(x_{nm}y_{nm}) - L_i L_p\|$$

$$= \frac{1}{kj} \sum_{nm}^{kj} \|T(x_{nm})T(y_{nm}) - L_i L_p\|$$

$$= \frac{1}{kj} \sum_{nm}^{kj} \|T(x_{nm})T(y_{nm}) - L_i T(y_{nm}) + L_i T(y_{nm}) - L_i L_p\|$$

$$\leq \frac{1}{kj} \sum_{nm}^{kj} \|T(y_{nm})\| \frac{1}{kj} \sum_{nm}^{kj} \|T(x_{nm}) - L_i\| + |L_i| \frac{1}{kj} \sum_{nm}^{kj} \|T(y_{nm}) - L_p\|$$

$$< \frac{\epsilon^2}{2\alpha} + |L_i| \frac{\epsilon}{2|L_i|} < \epsilon.$$

Hence, the set

$$\{(n,m)\in N\times N: \frac{1}{kj}\sum_{nm}^{kj} \|T(x_{nm}y_{nm}) - L_iL_p\| \ge \epsilon\} \in I$$

In consequence, $(x_{nm})(y_{nm}) \in C_{nm}^I$. Therefore, C_{nm}^I is a sequence algebra.

The proof of C_{0nm}^I is a sequence algebra is proved in the same manner of the C_{nm}^I .

3. Conclusion

In this paper, we defined and studied some properties on C_{nm}^{I} and C_{nm0}^{I} spaces, as well as, the closed relation between them. On the other hand, those concepts let the researchers extend and prove new notions on these spaces taking into account double sequences in ideal spaces. Otherwise, during the developing of this paper, we had been thinking about the following question: Is the space C_{nm}^{I} solid ? It would be interesting to show or to prove this result which is an open problem.
